### 2008 BASEBALL TRAINING CAMPS

#### LITTLE SLUGGERS (LS)

Boys & Girls Ages 5-6 Cost: \$149

This is the perfect camp for your future Hall of Famer to experience the joy of playing America's pastime. Focusing on the fundamentals, our coaches will teach throwing, fielding, hitting, base running and defensive skills and also pass along their enthusiasm for the game! Student to instructor ratio 10 to 1 or less.



#### SOX TRAINING CAMPS #1 (STC1)

Ages 7-10 Cost: \$205

Runs 3 hours per day

STC 1 is the foundation upon which all of our camps have been built. This camp will focus on the essential aspects of baseball including base running, throwing, hitting, bunting, fielding and pitching. Campers will be grouped according to age and ability so that the more advanced camper can work on advanced techniques. Roving hitting and pitching instructors from the White Sox Academy will visit many of our camp sites to provide special focus through advanced teaching. Student to instructor ratio 10 to 1 or less.

#### WHITE SOX TRAVEL PLAYER CAMP (STC2)

Ages 10-13 Cost: \$205

Runs 3 hours per day • **Must be on a travel team, or have completed STC1**

Attention travel players! This new camp from the White Sox is just for you. You have special, more advanced needs and the Travel Player Camp is just the ticket. This camp will be run like a Major League Spring Training practice with emphasis on reading pitchers, bunting for a base hit, cutoffs, advanced outfield and middle infield play, zone hitting, PFP, linear and rotational hitting and other techniques that you can use in that night's travel ball game. Requirements: Players must be ages 10-13 and have completed STC-1 or be playing for a travel team. Student to instructor ratio 10 to 1 or less.
